



## Fishing regulations for rivers as of 1.1.2025

### Fishing duration in the respective areas:

Saalach	1 March to 31 December
Siezenheimer Mühlbach	1 March to 30 November
Salzach	1 March to 31 December
Upper Glan and Glanüberwasser	1 March to 30 November
Untere Glan and Lieferinger Mühlbach	1 March to 30 November

### Fishing time:

From sunrise to sunset (see daily newspaper, smartphone or internet).

### Fishing gear and equipment:

The licence is valid for one (Salzach: two) rod(s), each with a single hook. In the fly season, fishing with a fly pole without casting weight is permitted (jumpers allowed). Multiple hooks are generally prohibited and may not be used on spoons, twisters, etc. or on systems with dead baitfish. Each fisherman must carry a pair of release pliers, a tape measure and a suitable writing instrument (no pencil, etc.).

### Daily and annual catch:

4 fish per licence and day, including 2 brown trout and one grayling. After reaching the day's catch, fishing must be stopped. An annual licence entitles the holder to catch a maximum of 100 fish per area and year, of which 25 are brown trout and 10 are grayling. Once the annual catch has been reached, the licence loses its validity regardless of the duration of fishing in the respective area. Multi-day tickets must contain the full daily entry before the start of fishing.

Every fish that is taken must be entered indelibly in the permit or in the catch book immediately after it has been caught and before fishing is resumed. The fish caught must be kept with him at the fishing spot and shown to the supervisory bodies on request.

### Minimum dimensions and closed seasons:

Grayling	35 cm	1 January to 31 May
Brown trout	30 cm	1 October to the end of February
Brook trout	30 cm	none
Rainbow trout	30 cm	none
Burbot	35 cm	December 1 to March 31
Danube salmon	85 cm	1 February to 31 May
Barbel	35 cm	1 May to 15 June
Nose	-	Protected all year round
Koppe	-	1 March to 31 May
Minnow / Pfrille	-	1 April to 30 June

For all other fish, the legal closed seasons and minimum sizes apply. Undersized fish or fish caught in the closed season must be released with the greatest care.

### Allowed baits:

Saalach upper reaches (downstream from the state border river kilometre 11.80) to the upper edge of the cascades/three-stage weir (river kilometre 9.20):

During the entire fishing season, fishing is only allowed with fly rods and artificial flies.

Middle Saalach (downstream from river kilometre 9.20 to river kilometre 3.40):

From the start of fishing up to and including 15 April and from 1 October until the end of the season with artificial fly. From 16 April to 30 September inclusive with artificial fly, trout spoons, soft baitfish, dead bait fish on single hooks. The use of multiple hooks is generally prohibited.

Saalach reservoir Rott (river kilometre 3.40 to the dam wall of the Rott power plant):

All legally permitted baits may be used on a single hook per rod. The use of multiple hooks is generally prohibited.

Saalach lower reaches (Rott/Freilassing road bridge to the mouth of the Salzach):

From the start of fishing up to and including 15 April and from 1 October until the end of the season with artificial fly.

From 16 April to 30 September inclusive with artificial fly, trout spoons, soft baitfish, dead bait fish on single hooks.

The use of multiple hooks is generally prohibited.

Entering the power plant site and the tossing basin (outlet) is prohibited by law.

Salzach:

All legally permitted baits may be used on a single hook per rod. The use of multiple hooks is generally prohibited.

Siezenheimer Mühlbach:

From 1 March to 30 April and from 1 October to 30 November with artificial fly, trout spoons, rubber fish and dead bait fish on a single hook. The use of multiple hooks is generally prohibited. From 1 May to 30 September, all legally permitted baits may be used on a single hook.

Obere Glan, Untere Glan and Lieferinger Mühlbach, Glanüberwasser:

In the *Glanüberwasser* without exception with artificial fly or nymph. In all other parts of the Glan and Lieferinger Mühlbach, all legally permitted baits may be used on a single hook. The use of multiple hooks is generally prohibited.

### **Fishing by children:**

In the flowing waters, children under the age of 12 are only allowed to fish with an additional licence entered in the annual ticket or multi-day ticket. The catch of a child fishing with you is counted towards the daily catch of the licensee. The child must be in close proximity to the licensee, who is also responsible for the child's compliance with the regulations.

Upon payment of the licence fee and accompanied by an adult licence holder, children up to the age of 15 may fish without restriction without having to be in possession of an annual fishing licence from the Salzburg State Fisheries Association.

### **Other provisions:**

with the exception of silent bite alarms, the use of external technical aids of any kind (bait boats, drones, fish finders, underwater cameras, etc.) is prohibited. Fishing for side streams and fish ladders is prohibited.

The transfer of licenses is prohibited. Behaviour that is not in accordance with animal welfare, cruelty to animals as well as the violation of legal regulations or the above provisions will result in the immediate withdrawal of the licence, in addition to other administrative or criminal consequences. License fees already paid have been forfeited. The instructions of the supervisory bodies must be followed. According to the Salzburg State Fisheries Act, supervisory bodies are also entitled to check the contents of luggage and vehicles.
